<b>Mask</b>

Consistent with guidance from the 2020-21 school year, schools must develop and implement local protocols to enforce the mask requirements. Additionally, schools should offer alternative educational opportunities for students who are excluded from campus because they will not wear a face covering. <p>In limited situations where a face covering cannot be used for pedagogical or developmental reasons, (e.g., communicating or assisting young children or those with special needs) a face shield with a drape (per <a href="#">CDPH guidelines</a>) can be used instead of a face covering while in the classroom as long as the wearer maintains physical distance from others. <p><b>Physical Distancing</b></p>		
<p>Recent evidence indicates that in-person instruction can occur safely without minimum physical distancing requirements when other mitigation strategies (e.g., masking) are implemented. <p><b>Ventilation</b></p>		
<p>For indoor spaces, ventilation should be optimized, which can be done by following <a href="#">CDPH Guidance on Ventilation of Indoor Environments and Ventilation and Filtration to Reduce Long-Range Airborne Transmission of COVID-19 and Other Respiratory Infections: Considerations for Reopened Schools</a>.</p>	<p>The school has Marv 13 filters, and the filters are changed 3 times a year.</p>	<p>No change proposed</p>
<p><b>Stay home when sick</b></p>		

Getting tested for COVID-19 when symptoms are <b>consistent with COVID-19</b> will help with rapid contact tracing and prevent possible spread at schools.	The school has COVID-19 protocols. Suppose the student or staff member has a temperature over 100.4, the student or staff member will be COVID-19 tested by the school nurse. Students require parent permission.	No change proposed
Advise staff members and students with symptoms of COVID-19 infection not to return for in-person instruction until they have met CDPH criteria to return to school	The school has COVID-19 protocols.	No change proposed
<b>Screening</b>		
CDPH has a robust State- and Federally-funded school testing program and subject matter experts available to support school decision making, including free testing resources to support screening testing programs (software, test kits, shipping, testing, etc.). <b>Contact Tracing</b>		
Per AB 86 (2021) and California Code Title 17, section 2500, schools are required to report COVID-19 cases to the local public health department.	The school have COVID-19 protocols in place.	No change proposed
Schools or LEAs should have a COVID-19 liaison to assist the local health department with contact tracing and investigation.	Schools have COVID-19 protocols in place. (Mrs. Butler is the school liaison).	The school nurse will contact student's families for contact tracing.

<b>Isolation rooms</b>		
For both vaccinated and unvaccinated persons, follow the CDPH <a href="#">Isolation Guidance</a> for those diagnosed with COVID-19.	The school has an isolation room for staff and students. <b>Hand Hygiene</b>		
Promote hand washing throughout the day, especially before and after eating, after using the toilet, and after handling garbage, or removing gloves.	The school promotes hand-washing hygiene and has Bathroom protocols.	No change proposed
<b>Cleaning</b>		
In general, cleaning once a day is usually enough to sufficiently remove potential virus that may be on surfaces. Disinfecting (using disinfectants on the <a href="#">U.S. Environmental Protection Agency COVID-19</a> list) removes any remaining germs on surfaces, which further reduces any risk of spreading infection. <b>Food Service</b>		
Maximize physical distance as much as possible while eating (especially indoors).
